Games:	There are 45 games to be conducted for this Promotion. See Table A below for the entry opening and closing times for each game.
Eligible entrants:	Entry is only open to Australian residents who are 18 years and over and are a Telstra customer with any Telstra mobile service.
How to Enter:	<p>The Promoter will run a live video on the Telstra Facebook page (www.facebook.com/Telstra) and the Telstra Twitter Page (https://twitter.com/Telstra) at various times during the Promotional Period. There is a total of nine (9) rounds for this Promotion (with each round composed for five (5) games).</p> <p>Three (3) digits will be selected using a bingo "lotto" ball machine for each game. The time the three (3) digits will be selected and displayed during the Facebook/Twitter live video for each game is indicated in Table A. The Facebook/Twitter live video will be broadcasted from 400 George Street, Sydney, NSW 2000.</p> <p>If an entrant has the three (3) digits drawn for that game in their mobile phone number.
